

DOCS REGISTRATION PROCESS

This document explains the DOCS registration process, with associated forms and payments that are required in each step. All of these forms can be viewed and printed from the "Forms" page of our website, www.ydocs.org/forms.php

STEP 1. USA REGISTRATION - This step will establish your child's place on the team. There one form and one payment during this step. There is one extra form required for swimmers transferring from another team. *We recommend you read the document "General Information About Our Swim Team" before registering.*

Form 1 – "Athlete Registration Application"

Form 1a – "USA Swimming – Transfer Request" - Required only if your child is transferring from another team.

Payment 1 - \$85, consisting of \$60 for LSC/USA Swimming fees and \$25 for DOCS

STEP 2. DOCS REGISTRATION - This step will occur at a later date, after all swimmers have completed the pre-registration step. ALL swimmers are required to fill out forms 4-7 and make payment #2.

Form 2 – "Illinois Swimming – Medical History Questionnaire"

Form 3 – "DOCS Code of Conduct"

Form 4 – "DOCS Master Consent and Waiver"

Form 5 – "DOCS Registration" (Fill out the form for your practice site)

Payment 2 – This payment to DOCS will vary, depending upon the practice site and practice options selected on the "DOCS Registration" form.

Your athlete has the option whether to join the Greater Peoria Family YMCA.

Option 1. DO NOT JOIN – You are done with step 2 of the registration process. This means your athlete is *not* eligible to swim in Y meets. However, he/she *is* eligible to swim in ISI meets.

Option 2. JOIN – You must complete the rest of step 2 below. Choosing this option makes your athlete eligible for all competitions, including Y meets and ISI meets. Your athlete is also a member of the Y and is free to use their facilities.

Form 6 – "Greater Peoria Family YMCA - Membership Application"

Form 7 – "Greater Peoria Family YMCA - Registration"

Payment 3 – Dues paid to the Greater Peoria Family YMCA as specified on the YMCA Registration form (#9).

STEP 3. MEET COMMITMENTS – You must decide whether your athlete will participate in competition meets during the season. If you decide NOT to compete, you are done registering and can skip step 3. If your athlete will compete, the forms and payment below must be completed by the next exact due dates that is posted.

Form 8 – "Junior Team Meet Commitment Form" – complete this form if your athlete is not a member of our Y Team, but he/she will compete in ISI meets.

Form 9 – "Y Team Meet Commitment Form" – complete this if your athlete joined the YMCA and will compete in ISI and Y meets.

Payment 4 – Pay \$75 to DOCS, which will be put in your meet escrow account to cover your athlete's meet expenses (meet fees, payment of coaches that travel to meets, etc).
